Customer Duty Preparation For Tent Fumigation

1. When fumigating all foods must be removed (including refrigerator/freezer) or doubled bagged in Nylofume bags and sealed. **All** dairy products and fresh fruit/ vegetables must be removed unless they are in "air-tight" containers (not cardboard). Examples of items that may remain in the building are unopened can foods and sealed bottles. **There will be a fee of \$150.00 assessed if we have to remove any food.** _____ (Initials)
2. All medications must be removed unless in "gas tight" container.
3. All living plants and animals (feral or domesticated) must be removed from inside and under the structure. This is the homeowners' responsibility.
4. All pilot lights must be extinguished (hot water heaters, ranges, ovens, broilers, ext). The re-lighting of all pilot lights is the responsibility of the homeowner. Note: Gas must be turned off, this is the homeowner's responsibility.
5. Baby crib mattresses and all plastic coverings on mattresses must be removed.
6. In order to insure proper fumigation and aeration of your building, all cabinets, drawers, appliances, and closets must be opened a minimum of 4 inches. Also raise blinds, open curtains, and attic vents.
7. Occupants must vacate the building a minimum of 3 days.
8. During the fumigation procedure and aeration period, the company will not be held responsible for vandalism, theft, or breaking and entering. If you are concerned, we recommend you obtain a watchman or guard.
9. The law requires that all buildings be locked during the fumigation. It is important that you make key arrangements with the company representative.
10. All doors under the tarp must be able to be locked. This includes any attached sheds with single doors. Entrance must be accessible by the certified operator. If the certified operator has to install a lock in order to be compliant with state regulations, our company will not be responsible for any damage that may occur to the door jams and facings.
11. It is required by law that we install secondary locks on all entrances to the structure. DO NOT tamper with these locks. We will not be responsible for damage to your lock as a result of the secondary lock being tampered with.
12. Any plants closer than 18 inches to the building or vines attached to the building must be removed. Bark chips, stones, or other ground coverings need to be raked back 18 inches from the building. **A \$150.00 fee will be assessed if this isn't done.** _____ (Initials)
13. Awnings must be lowered whenever possible.
14. Access to electricity is required. If access to electricity is not provided, a generator will be rented at the homeowner's expense, an average charge of \$150.00. _____ (Initials)
15. Grass may die about 18 inches from the building due to exposure of gas. There is no known way to prevent this reaction.
16. Although, we take pride in being careful while working on the roof, our company assumes no responsibility for broken tiles.
17. It is virtually impossible to do fumigation on buildings with tin roofs without some denting or bending on the corners, therefore, our company assumes no responsibility for roof damage.
18. When masking tape must be used, we cannot assume responsibility for the paint lifting off when removed.
19. If screen removal is necessary it will be the sole responsibility of the customer to have screens removed and replaced. We will not put tarps over pool cages. If the pool screens are not disconnected prior to our arrival, they will be cut. The company will not accept any responsibility for screens.
20. The company is not responsible for removing fences. Any fences attached to the side of the building must be removed. **There will be a \$150.00 fee assessed if we have to disconnect or remove fences. Following the fumigation, we will not be reconnecting or restoring any fences.** _____ (Initials)
21. Any underground drains, water pipes, or electrical conduits need to be disconnected. This is the homeowners' responsibility.
22. We will not be responsible for the denting of gutters. We have to get the tarps up on the roof by way of ladders that lean against the house. If you are concerned, you may have a lift there (at your expense) for us to use to get the tarps on the roof.
23. We will not be held responsible for broken sprinklers. If you are concerned, feel free to unscrew the sprinklers prior to our arrival.
